BUYER(S) FURTHER UNDERSTANDS THAT THE LISTING AGENT REPRESENTS ONLY THE SELLER (S) INTEREST, AND IN THAT CAPACITY, HAS A RIGHT TO REPRESENT HIS OWN BUYER CLIENT IN THAT SAME TRANSACTION SHOULD THAT POSSIBILITY ARISE.

In the event of a telephonic conference presentation Buyer(s) releases Buyer(s) Designated Agent from any liability resulting in the advance disclosure of the Buyer(s) contract to purchase to the Listing/Seller(s) Agent.

The Buyer understands that, by written direction, the Seller(s) may exclude Buyer(s) Designated Agent from witnessing the presentation to the Seller(s) of the Buyer(s) contract to purchase. In such event, Buyer(s) will be furnished a copy of the written direction and may direct the Buyer(s) Designated Agent to either WITHDRAW their contract to purchase or proceed on the basis of the Buyer(s) Designated Agent not being permitted at the presentation of the Buyer(s) contract to purchase to the Seller.

The Buyer(s) authorizes the Buyer(s) agent to fax or present a copy of this direction to the Seller(s) agent and/or Seller(s)
